

JOB TITLE: Special Testing Technician/ Cardiographic Technician

REPORTS TO: Clinic Manager FLSA STATUS: Non-Exempt

JOB OVERVIEW: This position under supervision by a cardiologist performs prescribed non-

invasive cardiovascular procedures and stress testing to patients. Duties include scheduling, explaining procedures to patients, monitoring their responses to tests, equipment maintenance, and detailed record keeping/reporting ensuring optimal care/treatment to our patient population.

# ESSENTIAL FUNCTIONS INCLUDE BUT ARE NOT LIMITED TO:

1. Prepares patients, equipment and materials used in diagnostic procedures.

- 2. Operates, calibrates and maintains diagnostic equipment and records the patient's response.
- 3. Prepares preliminary reports for final interpretation by the cardiologist.
- 4. Perform exercise, cardiac, nuclear, pharmaceutical, echo stress tests, Holter testing and analysis, EKGs as prescribed.
- 5. Recognizes chest pain, arrhythmias, life-threatening arrhythmias associated with stress testing responds/ obtains appropriate and immediate assistance as needed.

# ADDITIONAL RESPONSIBILITIES:

- 1. Ensures an accurate and readable recording using deductive reasoning to trouble shoot minor problems, make adjustments as needed during the procedure and prepares recordings for interpretation.
- 2. Collects and/or reviews pertinent medical, historical, and medication information in order to perform the appropriate study prescribed by the physician.
- 3. Works with physicians and serves as the technical expert on our various Non-Invasive testing applications.
- 4. Assists with computerized charting and order entry.
- 5. Assists with activities to improve department processes, facilitate testing and maintain quality to achieve optimal patient results.
